**Minutes of the 2010
Annual Members Meeting
Forest Hill Home Owners, Inc.
November 9, 2010**

On Tuesday, November 9, 2010, Forest Hill Home Owners, Inc. held its annual meeting of members at the A.M. McGregor Home in East Cleveland. Approximately 27 Forest Hill residents attended the meeting.

Jeff Dross, Forest Hill Newsletter Editor, welcomed everyone and introduced Marla Zwinggi, Past Secretary of Forest Hill Home Owners, Inc. Marla, in turn, introduced the speaker and a good friend of hers, Debbie Berry. Ms. Berry is the Vice President of Community Development, University Circle, Inc. She delivered an informative slide show of her organization's ideas and goals for the development, services and advocacy of the variety of businesses and non-profits in University Circle.

Tony Rupic gave the financial report for the past 10 months of 2010. He showed that the boiler in the cottage was replaced this year, and noted that membership dues were low. Altogether FHHO is showing a loss of around \$4,400.00 in income for the year. This is the first loss in about 7 years. **A MOTION** to accept the financial report was made by Dale Rothenberger and seconded by M. Sandra Truett. **PASSED**

Next there was a discussion regarding what to do to get better participation in the association and attendance at the annual meeting. Some of the comments were as follows:
