ARTICLES OF INCORPORATION OF C212 638

The undersigned, a majority of whom are citizens of the United States, desiring to form a corporation, not for profit, under the General Corporation Act of Ohio, do hereby certify:

FIRST. The name of said corporation shall be Forest Hill Home Owners, Inc.

SECOND. The place in this State where the principal office of the corporation is to be located is the City of Cleveland Heights, Cuyahoga County.

THIRD. The purpose or purposes for which said corporation is formed are:
